In accordance with the agreement, LFJCC performs all necessary advisory, management and administrative services described in the agreement. LFJCC is entitled to retain any positive results from operations and is responsible for any negative results from operations. The transfer of operational overhead from CJC to LFJCC was \$100,190 for the year ended June 30, 2015.
