- Dates: Wednesday July 25, through Thursday, July 26, 2012
- Itinerary: Wednesday July 25th: Leave JCC at 9a.m. and go to Knott's Berry Farm
*If you take a bus we will leave as soon as the last bus arrives.

Thursday, July 26 regular camp Activities at JCC
(Schedule subject to change at the Director's discretion)
- Lodging: Lawrence Family JCC- Wednesday, June 27, 2012
- Clothes: Shorts, shirts, hat, sunglasses, long pants, jacket, sweatshirt, comfortable closed toe walking shoes, socks, sleeping attire, bathing suit, towel, underwear, toiletries, suntan lotion, towel, sleeping bag, and a pillow.
All campers are required to wear their camp T-shirt for the Knott's Berry farm trip on Wednesday.
- Lunch: Bring a lunch for Wednesday, July 25th (except those who ordered camp lunches).
All other food will be provided for the trip.
- Money: All expenses for this trip have been included in camp fees. Please do not send more than \$30 for snacks and souvenirs. All money brought will be each camper's responsibility.

Extensive plans have been made to ensure that this will be a fun and safe trip for all participants. It is the camp's expectation that all campers will behave in an appropriate manner, adhering to the leadership of the staff. Any misconduct will result in the parents being notified and the camper being sent home immediately at the parents' expense.
